RULES: This is a talent search for short acts such as singing (solo, duets, up to quartet); 3-piece or less bands; impersonators; stand-up comedians; and other type of **family friendly** entertainment. We reserve the right to remove/end acts deemed not appropriate for family audiences.

JUDGING: Contestants will be judged on entertainment quality, performance, appropriateness of dress or costume and overall stage presence, uniqueness, and other elements which are brought to the stage. Contestants are encouraged to think of performance as a whole (dressing appropriately to the song you sing, dressing like the original performer, etc.). We are looking for entertainment, not just good vocals. Points will be deducted for going over the time limit. Singers and acts may be accompanied by a karaoke CD with instrumentation/sound effects and backup vocals only. NO LEAD VOCALS. Label CD with title of music, performer name, and correct track for performance. Audition stage is a small area so consider this when designing your act for the audition.

TIME LIMIT FOR AUDITIONS IS THREE (3) MINUTES; TIME LIMIT FOR FINALS IS FOUR (4) MINUTES. Auditions may be abbreviated to allow more contestants due to time limitations.
